The Company's basic policy for the return of profit to shareholders is to maintain stable dividends and raise dividends together with share buy-backs and retirement of treasury shares.

Considering the basic policy and the Company's current business performance, the Company intends to propose ¥21 of the year-end dividend per common share.

Accordingly, including the interim dividend of ¥21 per common share already paid, the annual dividend per common share for the fiscal year ending December 31, 2021 will be ¥42, which will be ¥6 increase from the previous year ended December 31, 2020.
